

In W.P.No 281/2002, the Division Bench of Indore High. Court passed the following Order on 13/2/2002:

directed that slaughtering of animals at a public place during the Mela period commencing from 17-2-2002 to 28-2-2002 shall not be done by the respondent Nos. 4 to 8 and anyone connected with organising the said meta, if any, such slaughtering of animals is noticed by the respondents No. 1 to 3, then they would take appropriate action in the matter against such person and would comply with the argument order in letter and spirit...."
