THE WILD LIFE (PROTECTION) AMENDMENT BILL, 2013

A BILL

further to amend the Wild Life (Protection) Act, 1972.

BE it enacted by Parliament in the Sixty-fourth Year of the Republic of India as follows:

Clause 26.—This clause seeks to substitute sections 51 and 51A of the principal Act relating to penalties and certain conditions to apply while granting bail. It provides that any person who contravenes any provision of the Act or any rule or order made there under, or terms and conditions of any licence or permit granted under the Act, shall be guilty of an offence and shall, on conviction, be liable to be punished in the manner specified under sub-sections (2) to (7).


It further provides that where the offence relates to any animal specified in Schedule I

or Part II of Schedule II or the meat of such animal or **animal article**, trophy, or uncured trophy derived from such animal, such offence shall be punishable with imprisonment for a term which shall not be less than five years but may extend to seven years and also with fine which shall not be less than one lakh rupees but may extend to twenty-five lakh rupees and in the case of a second or subsequent offence, of the nature mentioned in this sub-section, the term of imprisonment shall not be less than seven years and also with fine which shall not be less than seven years and also with fine which shall not be less than seven years and also with fine which shall not be less than seven years and also with fine which shall not be less than seven years and also with fine which shall not be less than five lakh rupees but may extend to fifty lakh rupees.


