Chapter 1

Preface

२७ जनवरी २०१४ को भारत सरकार ने जैन समाज को राष्ट्रीय स्तर पर अल्पसंख्यक का दर्जा प्रदान किया। भारतीय संविधान में अल्पसंख्यक समुदाय की सुरक्षा, शिक्षा, स्वरोजगार एवं सक्षमीकरण के कई विशेष प्रावधान है। इसे क्रियान्वित करने के



उद्देश्य से भारत सरकार ने अल्पसंख्यक विभाग एवं अल्पसंख्यक आयोग का गठन किया है। जनवरी २०१४ तक मुस्लिम, बौद्ध, क्रिश्चयन, सिख एवं पारसी धर्मों को अल्पसंख्यक दर्जा प्राप्त था। अब जैन धर्म को भी यह अधिकार प्राप्त है।

तैन समाज को अल्पसंख्यक दर्जा मिलना चाहिए या नहीं इस पर मतिभन्नता है। कुछ लोगों को ऐसा लगता है कि, जैन समाज को अल्पसंख्यक का दर्जा प्राप्त होने से जैन समाज मुख्य प्रवाह से दूर हो जायेगा। कुछ लोगों को लगता है कि, इस घोषणा से जैन समाज को आरक्षण का दर्जा मिलेगा जो कि निम्न जाति के लाभ के लिए है। यह मतिभन्नता संपूर्ण जानकारी के अभाव की वजह से है। अल्पसंख्यक का दर्जा मिलने की वजह से, जैन समाज इस देश के मुख्य प्रवाह से दूर हो जायेगा, ऐसा संभव ही नहीं है। ना ही अल्पसंख्यक वाने आरक्षण है। इसके विपरित अल्पसंख्यक दर्जा मिलने से जैन समाज के सभी धर्मस्थल, धार्मिक संस्थाएँ, संस्कृती, भाषा व लिपी सुरक्षित रहेगी। जैन समाज अपनी रूचि के अनुसार शैक्षणिक संस्थाओं की स्थापना कर सकेगा और उसका प्रशासन भी कर सकेगा। जैन समाज आर्थिक दृष्टी से सुसंपन्न समाज है, ऐसी धारणा है, यह अंशत: सत्य भी है। तथापि इस समाज में बहुत बड़ा मध्यम वर्ग है व अल्प आय प्राप्त करने वाला वर्ग भी है। जिन्हें दैनंदिन जीवन जीने के लिए अत्यधिक कठिनाई का सामना करना पड़ता है।

भारत सरकार द्वारा अल्पसंख्यक समाज के उत्थान की अनेक योजनाओं के लिए प्रति वर्ष करोडों रूपये का प्रावधान बजट में किया जाता है। अल्पसंख्यक दर्जा मिलने की वजह से अब जैन समाज को भी इन सारी योजनोओं में हिस्सा लेने का एवं विविध योजनाओं को क्रियान्वित करने का अधिकार प्राप्त होगा । यह जैन समाज के उत्थान के लिए बडी बात है।

देश में आंध्रप्रदेश, छत्तीसगढ, दिल्ली, हरियाणा, झारखंड, कर्नाटक, मध्यप्रदेश, महाराष्ट्र, पंजाब, उत्तरप्रदेश, उत्तरांचल, आसाम, पश्चिम बंगाल, त्रिपुरा इन राज्यों में जैन समाज को पहले से ही राज्यस्तर पर अल्पसंख्यक दर्जा प्राप्त था। इन सभी राज्यों में राज्यस्तर के अल्पसंख्यक योजनाओं का लाभ उन उन राज्यों के जैन समाज के लोगों को मिल रहा है। राष्ट्रीय व राज्य स्तर पर अल्पसंख्यक की योजनाओं में काफी भिन्नता है। अल्पसंख्यक समाज के उत्थान के लिए राज्य स्तर की योजनाओं से काफी ज्यादा योजनाएँ राष्ट्रीय स्तर पर उपलब्ध है। जैन समाज के विद्यार्थियों कि शिक्षा एवं छात्रवृत्ति कि विविध योजनाएँ, श्रेक्षणिक संस्थाओं कि स्थापना एवं प्रशासन की विविध योजनाएँ, युवतियाँ एवं महिलाओं के सक्षमीकरण की योजनाएँ, व्यवसाय के विकास की विभिन्न योजनाएँ, धर्मस्थान की सुरक्षा की विभिन्न योजनाएँ एवं स्वयंसेवी संस्थाओं के माध्यम से समाज उत्थान की विविध योजनाएँ उपलब्ध है। हाल ही में राष्ट्रीय स्तर पर जैन समाज को अल्पसंख्यक दर्जा प्राप्त होने की वजह से इन सभी योजनाओं की जानकारी जैन समाज के घर घर तक पहुँचाना आवश्यक है।

भारतीय जैन संघठन सन १९८५ से देशभर में सामाजिक उत्थान एवं शैक्षणिक विकास का कार्य कर रहा है। देश में जैन समाज के विभिन्न संस्थाओं द्वारा २५०० शैक्षणिक संस्थाओं का निर्माण सों डेढ़सों वर्ष पूर्व किया गया। इन शैक्षणिक संस्थाओं के माध्यम से, सभी जाति-धर्म के जरूरतमंद विद्यार्थियों को शिक्षा, सेवा के रूप में प्रदान की जाती है। भारतीय जैन संघठन द्वारा सन २००२ में फेडरेशन ऑफ जैन एज्युकेशन इन्स्टिट्यूट की स्थापना की गई। जैन समाज की १७०० शैक्षणिक संस्थाएँ इस फेडरेशन का हिस्सा है। राष्ट्रीय स्तर पर जैन समाज को अल्पसंख्यक दर्जा प्राप्त होने की वजह से इन शैक्षणिक संस्थाओं को विकास के अनेक अवसर प्राप्त होंगे।

केंद्र सरकार का अल्पसंख्यक कानून, अल्पसंख्यक विभाग, अल्पसंख्यक आयोग, प्रधानमंत्री १५ सूत्री कार्यक्रम एवं संबंधित अन्य विभाग तथा वेबसाईट का अध्य्यन कर, भारतीय जैन संघठन द्वारा ६ पुस्तका का सकलन किया गया है। आशा है कि, निम्निलिखित पुस्तकों के माध्यम से अल्पसंख्यक योजनाओं व लाभ की जानकारी जैन समाज के सभी वर्गों को आसानी से उपलब्ध हो सकेगी।

Chapter 2

Scheme Of Pre-Matric Scholarship

Background

The Prime Minister's New 15 Point Programme for the Welfare of Minorities was announced in June, 2006. It provides that a pre-matric scholarship scheme for meritorious students from minority communities would be implemented.

Objective

The scholarship at pre-matric level will encourage parents from minority communities to send their school going children to school, lighten their financial burden on school education and sustain their efforts to support their children to complete school education. The scheme will form the foundation for their educational attainment and provide a level playing field in the competitive employment arena. Empowerment through education, which is one of the objectives of this scheme, has the potential to lead to upliftment of the socio economic conditions of the minority communities.

Scope

The scholarship will be awarded for studies in India in a government or private school from class I to class X, including such residential Government institutes and eligible private institutes selected and notified in a transparent manner by the State Government and Union Territory Administration concerned.

Eligibility

Scholarship will be awarded to the students who have secured not less than 50% marks in the final examination and annual income of their parents/guardian from all sources does not exceed Rs. 1 lakh.

Distribution

Muslims, Sikhs, Christians, Buddhists, Zoroastrians (Parsis) and Jains have been notified as minority communities under Section 2 (c) of the National Commission for Minorities Act, 1992. The distribution of scholarship among the States/Union Territories will be made on the basis of population of minorities in the States/Union Territories of Census 2001.

Earmarking For Girl Students

30% of scholarship will be earmarked for girl students. In case sufficient number of eligible girl students are not available, then the balance earmarked scholarships may be awarded to eligible boy students.

Selection

As the number of scholarships for minorities available in a year is fixed and limited it is necessary to lay down preference for selection. Inter-se selection weightage is to be given to poverty rather than marks. In case of the renewal applications, such applications would be fully exhausted before the new applications are considered.

Duration

The scholarships will be provided for the entire course. Maintenance allowance will be given for 10 months only in an academic year.

Rate Of Scholarship

Actual financial assistance will be provided for admission/tuition fee and maintenance allowance as given below subject to a maximum ceiling indicated against item concerned:

* Hostellers include students who are staying in hostel of the school/institute concerned or those provided by the State Government/Union Territory Administration concerned.

Implementing Agencies:

The scheme will be implemented through the State Government/ Union Territory administration.

Conditions For Scholarship:

- i. Scholarship will be available to the students of minority community studying in Classes I to X. The continuance of award will be subject to securing 50% marks in the previous examination. Maintenance allowance will be provided to hostellers and day scholars.
- The award will be discontinued if a student fails to secure 50% marks in the annual examination except in case of unavoidable reasons to be certified by the Principal/competent authority of the school and recommended by the State Government/Union Territory Administration.
- iii. Scholarship will not be given to more than two students from a family.
- iv. Students should be regular in attendance for which the yardstick will be decided by the competent authority of the school.
- v. Income certificate should be on self-certification basis by way of affidavit on non-judicial stamp paper of self-employed parents/guardian and from employer for employed parents/guardian.
- vi. The school/institute will certify the claim of student of being an outstation student not residing in hostel of the school/institute concerned on the basis of permanent address and parents' address.
- vii. Migration of student from one school/institute to another would not normally be during the course of academic year except under exceptional circumstances and in the interest of student's academic career.

If a student violates school discipline or any other terms and condition of the scholarship, scholarship may be suspended or viii. State Government/Union The Administration can also directly cancel the award if duly satisfied of the reasons of violation of these regulations governing the scheme.

- If a student is found to have obtained a scholarship by false statement, his/her scholarship will be cancelled forthwith and ix. the amount of thescholarship paid will be recovered, at the discretion of the concerned State Government/Union Territory Administration.
 - The State Government/Union Territory Administration will lay down the detailed procedure for processing and sanctioning of Χ. scholarship to eligible students.
- credited to fee/Tuition fee will be Course school's/institute's bank account. Efforts will be made for xi. transferring it electronically through the banks.
- Maintenance allowance will be credited to the student's bank xii. account. Efforts will be made for transferring it electronically through the banks.
- The State Government/Union Territory Administration will xiii. maintain normal and records relating to the funds received from the Ministry and they will be subjected to inspection by the officers of the Ministry or any other agency designated by the Ministry.
- The student obtaining benefits under this scheme shall not be xiv. allowed to avail of benefits under any other scheme for this purpose.
- A student shall be eligible for only one scholarship for all XV. sources, i.e., SC/ST/OBC.
- The State Governments/Union Territory Administrations shall xvi. constitute a committee of the Departments implementing such scholarship schemes to ensure that the student from the minority community, who may also belong to children of those engaged in unclean occupation and OBC do not avail scholarship from other sources for the same purpose and avail only one source.

- The fund for distribution of scholarship in subsequent year will be released after receiving the utilization certificate for the previous year.
- The scheme will be evaluated at regular intervals by the Ministry or any other agency designated by the Ministry and the cost of the evaluation will be borne by the Ministry of Minority Affairs under the provision of the scheme.
 - xix. The State/Union Territory shall place all relevant details of financial and physical achievements on their website.
 - XX. The regulations can be changed at any time at the discretion of the Government of India.

Administrative Expenses

As the magnitude of data to be entered and processed would be enormous and the scheme gets implemented over the years, there would be a need to engage qualified skilled personnel right from the beginning to ensure that the data based computerized systems are operational. Qualified skilled personnel possessing requisite expertise to operate computer programme designed for this purpose, enter, process, analyse, monitor, retrieve and transfer data should be engaged on contract basis as per need. Data provided by the States/Union Territories will be maintained and managed by the Ministry with personnel of similar expertise to be engaged on contract basis.

A provision not exceeding 1% of the total budget will be made to meet the administrative and allied costs viz. expenditure of the States/Union Territories for office equipments including computers and accessories, furniture, printing of application forms, advertisement, engagement of personnel, etc. This provision will also be used for evaluation and monitoring of the scheme, through outside reputed institutions/agencies engaged by the Ministry of Minority Affairs, Government of India or by the State Governments/Union Territory administrations.

Renewal Of Scholarship

The scholarship, once awarded, may be renewed during next academic year of the course on the production of certificate that the student has secured 50% marks.

Announcement Of Scheme

scheme will be announced by the concerned State Government/Union Territory Administration well in time, by giving advertisements in the leading language newspapers and local dailies/vernacular and by using other suitable publicity media.

Mode Of Applying

The concerned State Government/Union Territory Administration will supply the application forms, till such time computerized systems are made operational by the State Governments/Union Territory Administrations. The application forms should be received back alongwith requisite certificates/certifications within the stipulated period.

Pattern Of Financial Assistance

Funding pattern between Centre and States will be in the ratio of 75:25. Union Territories will be provided 100 per cent Central assistance.

Monitoring & Transparency

The States/Union Territories implementing the scheme shall monitor the financial and physical performance of the scheme at State/Union Territory level. For this purpose, an I.T. enabled mechanism shall be in place. The State/Union Territory will be required to furnish quarterly financial and physical progress reports to the Ministry. The State/Union Territory shall maintain year-wise details of the students scholarship, indicating school/institute, school/institute, government or private, class, gender, new or renewal, permanent address and parents' address. The States/ Union Territories shall place relevant physical and financial details in their official website.

Evaluation

The monitoring of the financial and physical performance of the scheme will be evaluated by assigning evaluation/impact studies to reputed institutions/agencies by the Ministry of Minority Affairs, Government of India

- Q.1. What is the pre-matric scholarship scheme for minority communities?
- Ans. The objective of the scheme is to encourage parents from minority communities to send their school going children to school, lighten their financial burden on school education and sustain their efforts to support their children to complete school education.

Pre-matric scholarship scheme for minority communities provides the scholarship to students from class I to X studying in Government/ recognized private schools/ institutes in India. (See website:- www.minorityaffairs.gov.in)

Q.2. Who is eligible to apply for the pre-matric scholarship?

Ans. Students belonging to Muslim/ Christian/ Sikh/ Buddhist/ Parsi / Jain who has secured not less than 50% marks in previous final examination and the annual income of his/her parents/ guardians from all sources not exceeding Rs. 1 lakh, can apply for the prematric scholarship in the prescribed application to the Department dealing with minority welfare of his/her State/UT, on advertisement published by the State Government/ Union Territory Administration concerned.

Chapter 3 Scheme Of Post-Matric Scholarship

Background

The Prime Minister's New 15 Point Programme for the Welfare of Minorities was announced in June, 2006. It provides that a post-matric minority students scheme for meritorious scholarship communities would be implemented.

Objective

The objective of the scheme is to award scholarships to meritorious students belonging to economically weaker sections of minority community so as to provide them better opportunities for higher education, increase their rate of attainment in higher education and enhance their employability.

Scope

The scholarship is to be awarded for studies in India in a government or private higher secondary school / college / university, including such residential institutes of the Government and eligible private institutes selected and notified in a transparent manner by the State Government/Union Territory Administration concerned. It will also cover technical and vocational courses in Industrial Training Institutes/ Industrial Training Centres affiliated with the National Council for Vocational Training (NCVT) of classes XI and XII level.

Eligibility

Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardian from all sources does not exceed Rs.2 lakh.

Distribution

Muslims, Sikhs, Christians, Buddhists, Zoroastrians (Parsis) and Jains have been notified as minority communities under Section 2 (c) of the National Commission for Minorities Act, 1992. The distribution of scholarship among the States/Union Territories will be made on the basis of population of the above notified minorities in the States/ Union Territories of Census 2001.

Earmarking For Girl Students:

30% of scholarship will be earmarked for girl students. In case sufficient number of eligible girl students are not available, then the balance earmarked scholarships may be awarded to eligible boy students.

Selection Procedure

Unlike scholarship for SC and ST, there are a fixed number of scholarships for minorities is small and limited. Students from BPL families, having the lowest income shall be given preference in the ascending order. The renewal applications would be fully exhausted before the new applications are considered.

Duration

Scholarship will be provided for the entire course. However, maintenance allowance will be given for a period not exceeding 10 months only in an academic year.

Rate Of Scholarship

Actual financial assistance will be provided for admission & course /tuition fee and maintenance allowance as given below subject to a maximum ceiling indicated against item concerned:

Implementing Agencies

The scheme will be implemented through the State Government/ Union Territory Administration.

Conditions For Scholarship

i. Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardian from all sources does not exceed Rs.2 lakh. Unlike scholarship for SC and ST, there are a fixed number of scholarships for minorities and hence preference for selection has been laid down. Students from BPL families, having the lowest income shall be given

- preference in the ascending order. The renewal applications would be fully exhausted before the new applications are considered.
- ii. The award will be discontinued if a student fails to secure 50% marks or equivalent grade in the previous final examination. Scholarship will not be awarded for more than the normal period of time taken to obtain certificate/degree/M. Phil degree/doctorate degree
- iii. Scholarships will not be given to more than two students in a family.
- iv. The students should be regular in attendance for which the yardstick will be decided by the competent authority of the school/college/university.
- v. Income certificate should be on self-certification basis by way of an affidavit on non-judicial stamp paper for self-employed parents and from employer for employed parents.
- vi. The school/college/university authority will certify the claim of the student of being an outstation students not residing in hostel of the institution concerned on the basis of permanent address and parent's address.
- vii. Migration of students from one institution to another would not normally be allowed during the course of the academic year except under exceptional circumstances and in the interest of the student's academic career.
- viii. If a student violates any other term and condition of the scholarship, the scholarship may be suspended or cancelled. The State Government/Union Territory Administration can also directly cancel the award if duly satisfied of the reasons of violation of these regulations governing the scheme.
 - ix. If a student is found to have obtained a scholarship by false statement/certificates, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid shall be recovered, at the discretion of the concerned State Government/Union Territory Administration.
 - x. The State Government/Union Territory Administration will lay down the detailed procedure for processing and sanctioning of scholarships to eligible students.
 - xi. Course fee/tuition fee will be credited to the school's/college's/institution's bank account. Efforts will be

made for transferring it electronically through the banks.

The State Government/Union Territory Administration will maintain a separate account and records relating to the funds received from the Ministry and they will be subjected to inspection by the officers of the Ministry or any other agency designated by the Ministry.

xiii. The student obtaining benefits under this scholarship scheme shall not be allowed to avail of benefits under any other

scholarship scheme for the same purpose.

The State Government/ Union Territory Administration shall constitute a committee of the departments implementing such scholarship schemes to ensure that the students from the minority community, who may also belong to SC/ST/OBC category, does not avail scholarship from other sources for the same purpose and avail only from one source

xv. The fund for distribution of scholarships in subsequent years will be released after receiving the utilization certificate for the

previous year.

The scheme will be evaluated at regular intervals by the Ministry or any other agency designated by the Ministry and the cost of the evaluation study will be borne by the Ministry under the provision of the scheme.

xvii. The State/Union Territory shall place all relevant details of

financial and physical achievements on their website.

xviii. The regulations can be changed at any time at the discretion of the Government of India.

Administrative Expenses

As the magnitude of data to be entered and processed would be enormous as the scheme gets implemented over the years, there would be a need to engage qualified skilled personnel right from the beginning to ensure that the data based computerised systems are operational. Qualified skilled personnel possessing requisite expertise to operate computer programme designed for this purpose, enter, process, analyse, monitor, retrieve and transfer data should be engaged on contract basis as per need. Data provided by the States/Union Territories will be maintained and managed by the Ministry with personnel of similar expertise to be engaged on contract A provision not exceeding 2% of the total budget will be made to meet the administrative and allied costs viz. expenditure of the States/Union Territories and the Ministry for office equipments including computers and accessories, furniture, printing of application forms, advertisements, engagement of personnel, etc. This provision will also be used for evaluation and monitoring of the scheme, through outside reputed institutions/agencies engaged by the Ministry of Minority Affairs, Government of India and the State Governments/Union Territory Administrations.

Renewal Of Scholarship

The scholarship, once awarded, may be renewed during the next academic year of the course on the production of certificate that the student has secured 50% marks in the examination.

Announcement Of Scheme

The scheme will be announced by the concerned State Government/Union Territory Administration well in time, through advertisements in the leading language newspapers and local dailies and by using other suitable publicity media.

Mode Of Applying

The concerned State Government/Union Territory Administration will supply the application forms, till such time computerized systems are made operational. The application forms should be received back along with requisite certificates/certifications within the stipulated period.

Pattern Of Financial Assistance

100% funding will be given by the Central Government to the State Government/Union Territory Administration.

Monitoring & Transparency

The States/Union Territories implementing the scheme shall monitor the financial and physical performance of the scheme at the State/Union Territory level. For this purpose, an IT enabled monitoring mechanism shall be in place. The State/Union Territory will be required to furnish quarterly financial and physical progress reports to the Ministry. The State/Union Territory shall maintain year-wise details of the students receiving scholarship, indicating

school/college/institute, location of school/college/institute, government or private, class, gender, new or renewal, permanent address and parents address. The States/Union Territories shall place relevant physical and financial details in their official website.

Evaluation

The monitoring of the financial and physical performance of the scheme will be evaluated by assigning evaluation/impact studies to reputed institutions/agencies by the Ministry of Minority Affairs, Government of India.

Chapter 3b FAQs Of Post-matric scholarship

- Q.1. What is the Post-matric scholarship scheme for minority communities?
- Ans. The objective of the scheme is to award scholarships to meritorious students belonging to economically weaker sections of minority community so as to provide them better opportunities for higher education, increase their rate of attainment in higher education and enhance their employability.

Post-matric scholarship scheme for minority communities provides the scholarship to students from class XI to Ph.D (XI, XII, Technical/Vocational, Under Graduate, Post Graduate, M.Phil & Ph.D) studying in Government/ recognized private schools/ colleges/ universities/ institutes in India including technical/ vocational courses in Industrial Training Institutes/ Industrial Training Centers and the courses not covered under merit-cum-means based scholarship scheme for minority communities. This Scholarship is not available for LLB, MBA, MCA, BE and MBBS. (See website:-www.minorityaffairs.gov.in)

- Q.2. Who is eligible to apply for the post-matric scholarship?
- Ans. Students belonging to Muslim/ Christian/ Sikh/ Buddhist/ Parsi and Jain who have secured not less than 50% marks in previous final examination and the annual income of his/her parents/ guardians from all sources not exceeding Rs. 2.00 lakhs, can apply for the post-matric scholarship in the prescribed application to the Department dealing with minority welfare of his/her State/UT, on advertisement published by the State Government/ Union Territory Administration concerned.

Q.3. What is the financial assistance given under post matric scholarship?

Ans. Under post-matric scholarship, financial assistance for admission & course/tuition fee and maintenance allowance is given, as under:

Chapter 4

Scheme Of Merit Cum Means Based Scholarship

Objective:

The objective of the Scheme is to provide financial assistance to the poor and meritorious students belonging to minority communities to enable them to pursue professional and technical courses.

Scope:

These scholarships are available for studies in India only and will be awarded through an Agency designated by the State Government/UT Administration for this purpose.

How to Apply:

Students should apply online. For this they should visit the website through URL www.momascholarship.gov.in. A link to the site is also provided in the website of the Ministry of Minority Affairs, i.e. <a href="www.minorityaffairs.gov.in.

After opening the site they should select the name of the scholarship scheme, they wish to apply. Then they should go to the 'Student Registration' tab as appeared on the screen and register themselves for online application.

Students should carefully read carefully the 'FAQs for Students' as appeared in the Home Page of the Scholarship website.

Conditions for Scholarship

- i. Financial assistance will be given to pursue degree and/or post graduate level technical and professional courses from recognized institution. Maintenance allowance will be credited to the student's account. The course fee will be paid by the State Department directly to the institute concerned.
- Students who get admission to a college to pursue technical/professional courses, on the basis of a competitive examination will be eligible for the

scholarship.

courses without facing any competitive examination will also be eligible for scholarship. However, such students should have not less than 50% marks at higher secondary/graduation level. Selection of these students will be done strictly on merit basis.

iv. Continuation of the scholarship in subsequent years will depend on successful completion of the course during the

preceding year.

v. A scholarship holder under this scheme will not avail any other scholarship/stipend for pursuing the course.

- vi. The annual income of the beneficiary/parent or guardian of beneficiary should not exceed Rs.2.50 lakh from all sources.
- vii. The state department will advertise the scheme every year latest by 31st March and receive the application through the concerned institutions.
- viii. After scrutinizing the applications, the state department will prepare a consolidated budget for all eligible students and send an application in the prescribed pro-forma for release of fund from the Ministry of Minority Affairs for distribution of scholarship giving the details of each students viz. name, permanent address, telephone number, annual course fee, name & address of institute, whether hostler or day-scholar, etc.

ix. The application for release of fund from the state department must be received in the Ministry by 30th of September every year.

- x. The state department will maintain separate bank account and records relating to the funds received from the Ministry and they will be subjected to inspection by the officers of the Ministry or any other agency designated by the Ministry The fund for distribution of scholarship in subsequent year will be released after receiving the utilization certificate for the previous year. Annual inspection by the officers of the Ministry or any other agencies designated by the Ministry will also be carried out.
- xi. 30% scholarship will be reserved for girls of each minority community in a state which is transferable to male

- student of that community in case of non-availability of female candidate in that community in the concerned
- If the target for distribution of scholarship to a particular minority community in a state/UT is not fulfilled, it will xii. be distributed among the same minority community of other States/UTs strictly in accordance with the merit.
- A student residing in a particular State/UT will be xiii. entitled for scholarship under the quota of that State/UT only irrespective of his place of study.
- The number of scholarship has been fixed state-wise on xiv. the basis of minority population of the states/UTs. Within the state-wise allocations, the applications from reputed institutions will be exhausted first. The list of such institutions will be made available by the Ministry of Minority Affairs.
- The scheme will be evaluated at regular intervals and the XV. cost of the evaluation will be borne by the Ministry of Minority Affairs under the provision of the scheme. An additional provision of 3% of the total budget will be made administrative and allied costs viz. meet the to expenditure on monitoring of the scheme, impact study, evaluation study, purchase of office equipments, engaging of contract employees, if necessary and other expenditure to run the cell etc. This will be shared between the Ministry of Minority Affairs, Government of India and the State Governments/UT Administration.

Payment

Maintenance allowance is payable from 1st April or from the month of admission, whichever is later, to the month in which the examinations are completed, (including maintenance allowance during holidays) maximum twice a year, provided that if the scholar secures admission after the 20th day of a month, the amount will be paid from the month following the month of admission.

In case of renewal of scholarships awarded in the previous years, maintenance allowance will be paid from the month following the month upto which scholarship was paid in the previous year, if the course of study is continuous.

The Government of the State/Union Territory Administration, to which they belong, in accordance with the procedure laid down by them in this regard, will pay the scholarship money to the selected students.

Scholarship will not be paid for the period of internship/housemanship in the M.B.B.S. course or for a practical training in other course if the student is in receipt of some remuneration during the internship period or some allowance/stipend during the practical training in other course.

Other Conditions for the Award

i. The scholarship is dependent on the satisfactory progress and conduct of the scholar. If it is reported by the Head of the Institution at any time that a scholar has by reasons of his/her own act of default failed to make satisfactory progress or has been guilty of misconduct such as resorting to or participating penefits of Minority

in strikes, irregularity in attendance without the permission of the authorities concerned etc., the authority sanctioning the scholarship may either cancel the scholarship or stop or withhold further payment for such period as it may think fit.

If a student is found to have obtained a scholarship by false ii. statement, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of the concerned State Government. The student concerned will be blacklisted and debarred for scholarship in

any scheme forever.

A scholarship awarded may be cancelled if the scholar changes iii. the subject of the course of study for which the scholarship was originally awarded or changes the Institution of study, without prior approval of the State Government. The Head of the Institution shall report such cases to them and stop payment of the scholarship money. The amount already paid may also be recovered at the discretion of the State Government.

A scholar is liable to refund the scholarship amount at the iv. discretion of the State Government, if during the course of the year, the studies for which the scholarship has been awarded, is discontinued by him/her.

- Application complete in all respects shall be submitted to the Head of the Institution, being attended or last attended by the candidates and shall be addressed to an officer specified for this purpose by the Government of State/ Union Territory to which the student belongs, in accordance with the instructions issued by them from time to time.

Funding Pattern of the Scheme

The Scheme will be implemented by the State Governments and Union Territory Administrations, which receive 100% central assistance from Government of India for the total expenditure under the scheme.

Eligibility criteria

- i. Students, who have got admission in a recognized college to pursue technical/professional courses, on the basis of a competitive examination.
- ii. Students, who have got admission in a recognized college to pursue technical/professional courses, without facing any competitive examination, will also be eligible for scholarship. However, such students should have not less than 50% marks at higher secondary/graduation level. Selection of these students will be done strictly of merit.
- iii. A scholarship holder under this scheme will not avail any other scholarship/stipend for pursuing the course.
- iv. The annual family income of the beneficiary/parent or guardian of the beneficiary should not exceed Rs.2.50 lakh per annum from all sources.
- v. A student residing in a particular State/UT will be entitled for scholarship under the quota of that State/UT only irrespective of his place of study.

FAQs Of Merit-Cum-Means Scholarship

- Q 1. Which are the minority communities eligible for this scholarship?
- Ans: Minority communities notified under section 2(c) of NCM Act, 1922 are eligible for this scholarship scheme. They are:-Muslims, Christians, Sikhs, Buddhists, Parsis (Zoroastrians), Jains.
- Q 2: Who can apply for merit-cum means scholarship?
- Ans: Students belonging to minority communities can apply for this scheme for studies in India only to the State/UT to which they belong through this institute/college.
- Q 3. What are the eligibility criteria?

LICTICS OF WILL.

- Ans: The annual income of the student/parent or guardian of student should not exceed Rs.2.50 lakh from all sources and the student also should have secured at least 50% marks in his/her last examination
- Q 4. What are the courses for which scholarship is provided for?
- Ans: Financial assistance is provided forpursuing technical and professional courses at under-graduate and post-graduate levels in a institute recognized by an appropriate authority.
- Q.5. What are the technical and professional courses covered by the scheme?
- Ans: The list of eligible technical and professional courses are available in the website of the Ministry for Minority Affairs. Please visit Ministry's website www.minorityaffairs.gov.in

Q.6 How is the scheme implemented?

Ans: The scheme is implemented through the State Government/UT administration who receive 100% central assistance from the Government of India.

Q.7 What is the rate of scholarship?

Ans: Students studying in other recognized institutes are entitled for reimbursement of a maximum course fee of Rs.20,000/-per annum. Students, studying in listed institutions (Reputed institutions shorted listed all over India, a total of 70 such institutions are there country-wide) are eligible for full reimbursement of course fee charged by these institutions.

Q.8 What is the rate of maintenance allowance?

Ans: Maintenance allowance is given @ Rs.5,000/- and 10,000 for 10 months in a yea to day scholars and hostlers respectively.

Q.9 How does a student come toknow, whether he has been awarded scholarship or not?

Ans: The respective State/UTs Government should be approached for any specific information in this regard. Once scholar ships are sanctioned, the States/UTs are required to plan the details of the selected students in the website of State Government/department concerned.

Q.10 How are the scholarship distributed among the different minority communities and States/UTs?

Ans: State-wise distribution of scholarship among the students belonging to the five minority communities is given at booklet of the merit-cum means scholarship scheme. This has been done in proportion to the population of minorities of the States/UTs concerned. For details visit the website of the Ministry www.minorityaffairs.gov.in

Q.11 Is there any earmarking for girl students?

Ans: 30% scholarship has been earmarked for girls of each minority community in a state.

Q.12 What happens, if the earmarked number of scholarships for girls are not utilized?

Ans: In the meant 30% scholarships earmarked for girls of each minority community in a State/UTs is not fully utilized, it would be transferred to male students of that community in the State/UT concerned.

Q.13 When do I apply for fresh and renewed scholarship?

This advertisement should normally come out in the month of April every year. Chapter 5 Scheme Of Free coaching and Allied Scheme

(with effect from 2013-14)

1. Background

- 1.1. The scheme aims to empower the minority communities, which are relatively disadvantaged section of their skills and capabilities to make them employable in industries, services society, by assisting them as well as those institutions working for them, towards in-resilience to adapt itself to the market dynamics on a continuous basis so that the target groups are not deprived of the professional acumen demanded by the enhancing and business sectors in addition to the government sector. It has the built changing/emerging market needs and opportunities for employment at domestic as well as international levels
- 1.2. Separate schemes for providing coaching to students belonging to scheduled caste, minority communities and backward classes were being implemented from 6th Five Year Plan. These separate schemes were amalgamated with effect from September, 2001 into a combined Scheme of Coaching and Allied Assistance for Weaker Sections including Scheduled Castes, Other Backward Classes and Minorities. However, after the creation of Ministry of Minority Affairs, a new scheme called "Free Coaching and Allied Assistance for candidates belonging to the minority communities is being implemented by this Ministry. The scheme has been made more comprehensive keeping in view the emerging trends of employment in the era of economic reforms, liberalization and globalization.

- 2. Objectives
 The objectives of the scheme are to assist students belonging to the minority communities by way of special coaching for the following:-
 - Qualifying examinations for admission in technical/ professional courses such as engineering, law, medical, management, information technology etc. and language/aptitude examinations for seeking admission to foreign universities
 - ii. Competitive examinations for recruitment to Group "A", "B" and "C" services and other equivalent posts under the Central and State governments including public sector undertakings, banks, insurance companies as well as autonomous bodies; and
 - iii. Coaching/training for jobs in the private sector such as in airlines, shipping, fisheries, information technology (IT), business process outsourcing (BPO) and other IT enabled services, hospitality, tours and travels, maritime, food processing, retail, sales and marketing, bio-technology and other job oriented courses as per the emerging trend of employment. The duration of the courses should not exceed nine months.

3. Implementing agencies and eligibility

- A. The following types of organizations will be eligible for receiving financial assistance under this Scheme:-
 - All institutes in the government sector, including universities and autonomous bodies, engaged in coaching/training activities
 - Universities/colleges in Private Sector engaged in coaching/training activities, including deemed Universities.
 - iii. Institutes in the Private Sector engaged in coaching

activities/job oriented coaching/training for placement in private sectors, which are a Trusts, Companies, Partnership Firms, or Societies registered under Societies Registration Act, 1960.

- B. The following will be the eligibility criteria for receiving financial assistance under this Scheme:-
 - The institutes should have the required number of qualified faculty members either on its pay roll or on part-time basis
 - II. The institutes should have necessary infrastructure such as premises, library, requisite equipment etc. to run the coaching classes/training centers.
 - III. The institutes should have experience of imparting coaching/training in the relevant Course/Programme.
 - IV. Coaching institutes should have a minimum success rate of 15%. in respect of training institute; 50% placement, including self employment if they have been conducting coaching in the past year/s.
 - V. Coaching/training for industry specific courses/jobs will be encouraged for Private Sector jobs; like Plastic Technology etc.
 - VI. Ministry of Minority Affairs may empanel institutes to apply directly to the Ministry from time to time.

Details of procedure:-

- i. The Ministry of Minority Affairs will advertise the details of the scheme and invite proposals from the coaching/training Institutes. The Institutes selected for 2013-14 will be empanelled for the remaining period (of four years) in the XIIth Five Year Plan i.e. upto 2016-17.
- ii. While the Institutes in Government Sector can send proposals in the prescribed proforma, directly to the Ministry of Minority Affairs, the Organizations in the Private Sector, including Non-Governmental

organizations (NGOs) should submit their proposals through the State Government/UT Administration concerned.

- iii. The State Governments/UT Administrations will conduct necessary inspection of the projects and forward the proposals with specific recommendations to the Ministry of Minority Affairs (as per the set time line).
- iv. The proposals received under the Scheme will be scrutinized/processed in the Ministry and placed before the Selection Committee consisting of the following members, for consideration and approval:-

A. Joint Secretary concerned of Ministry of Minority Affairs

Chairperson

B. Director/Deputy Secretary (Finance)

Members

C. Representative from Ministry of HRD

Members

D. Representative of UGC

Members

E. Representative from Education Institutions

Co-opt Member

F. Director/Deputy Secretary of Ministry of Minority Affairs

Convener

5. Eligibility criteria for candidates/students

- Candidates must have secured the requisite percentage of marks in the qualifying examination prescribed for admission into the desired courses/recruitment examinations.
- Only candidates belonging to the Minority Communities, having total family income from all
- iii. sources not exceeding Rs.3.00 lakh per annum, will be eligible under the Scheme.
- iv. Benefits of coaching/training under the scheme can be availed by a particular student once only,
- v. irrespective of the number of chances he/she may be entitled to in a particular Competitive Examination. The coaching/training institution will be required to take an Affidavit from the student that he/she has not taken any benefit under this

Scheme earlier.

- vi. Students/Candidates covered under the scheme shall have to attend all classes. In the event of any student remaining absent for more than 15 days, without any valid reason or leaving the coaching/training midway, the entire expenditure incurred on the candidate will be recovered from the institute/student/candidate concerned.
- vii. 30% of the numbers sanctioned for coaching/training shall be earmarked for girl students/candidates. It may be transferred to boy students only in case girl students/candidates meeting the standards for coaching/training set by the institute are not available.

6. Funding

- 100 % financial assistance will be provided to the selected coaching/training institutes under the Scheme.
- ii. Stipend will be given by the Ministry for maintenance of the students/candidates. The details of the rates of financial assistance are given below:-

- iii. The grant-in-aid released by the Ministry shall be deposited directly into an account of the institute.
- iv. The grant-in-aid shall be released as per norms prescribed in the General Financial Rules and by the Ministry.
- v. Funds will be released to the selected institutes in two equal installments. The First Instalment shall be released once the list of selected students/candidates to be coached/trained is furnished by the institute to the Ministry of

Minority Affairs and also placed on the website of the institute. The Second Instalment will be released only on completion of the coaching/training course, submission of list of students/candidates trained/coached and their result/ outcome or placement status in the prescribed proforma.

vi. Government of India reserves the right to release funds in subsequent years after inspection of the organization by the Central Government/State Government/UT Administration or any other agency designated by the Ministry. The Government of India reserves this right exclusively to get inspection conducted in subsequent years.

7. Terms and conditions to be complied with by the coaching institutes

- i) The institute shall maintain full details of name, address, telephone number, e-mail i.d. (if available) etc. of the candidates enrolled for coaching/training programme and furnish this information to the Ministry.
- ii) The institute shall maintain full records of each candidate admitted like age, gender, educational qualifications, bank account number etc.
- iii) The admissible amount payable towards stipend shall be paid to the candidates on monthly basis directly into their bank accounts or through cheque.
- iv) Separate account will be maintained by the institute for the funds released by the Ministry and will be made available to the Ministry of Minority Affairs as and when requisitioned for inspection.
- v) The institutes shall utilize the funds for the specified purposes only. The grantee institute shall give an undertaking that in the event of acting in contravention of this condition, it will refund the amount received with 18% penal interest and any other action, as deemed proper by the Government.

- vi) The coaching/training institution will also be required to take an affidavit from the student that they have not taken benefit earlier under this scheme or any other similar scheme funded by the Government.
- vii) The institution shall submit a certificate accepting the terms and conditions laid down by the Ministry of Minority Affairs and furnish a bond with two sureties in the name of the competent authority responsible for actual implementation of the scheme and also responsible for furnishing of accounts of the grant sanctioned.
- viii) The institute shall be solely responsible for ensuring that only students of meritorious standing are admitted for coaching/training.
- ix) For enabling E-payment directly into the account of societies/NGOs/institutions/etc. through ECS, RTGS, NIFT, TTs system, an authorization letter from the payee, with full details of e-payment i.e. name of payee, bank IFC code number, bank branch number, bank branch name, bank branch address etc. should be provided. The authorization letter must be countersigned by the manager of the respective bank branch to avoid wrong account number. Only one authorization letter is required for the entire financial year or till the account number is changed during the year. A proforma of the authorization is annexed.
- x) After completion of the coaching/training programme, the institute shall immediately submit the utilization certificate and audited accounts, certified by a Chartered Accountant, to the Ministry of Minority Affairs, along with the following documents:
 - a. Income and expenditure account/balance sheet for the year, including receipt & payment account of the institute, in respect of funds received during the year
 - A certificate to the effect that the institution has not received any other grant for the same

purpose from any other Ministry/Department of the Government of India, State/UT Government and any other Government/Non-Government organization

- xi) The selected institute should be willing to mobilize its own resources for smooth conduct of the approved programme. They shall be duty bound to ensure that neither the coaching/training programme nor the payment of stipend to the enrolled candidates suffers due to delay, if any, in release of funds.
- xii) The coaching/training institute shall be informed of the in-principle approval, indicating the type of coaching/training, number of students/candidates and the estimated amount for sanction. The institute will be required to place advertisement in the local paper inviting applications from eligible students/candidates from the minority communities. The name of students selected for coaching/training along with details like address, community, gender and annual income should be submitted directly to the Ministry within the shortest time possible and not beyond a period of three months.
- xiii) The grantee institute shall furnish a certificate to the effect that it has paid the sanctioned amount of stipend to the students concerned.
- xiv) The grantee institute shall furnish a utilization certificate in the prescribed proforma (GFR-19A), running or final as the case may be, along with the application for release of second instalment for the year concerned or fresh application for another year".
- xv) The grantee institute will upload daily progress, relevant visuals etc. of coaching classes on the website/portal of the Ministry.

8. Monitoring:

Monitoring of the progress made by the grantee institutes will be carried out as follows:

- The institute shall submit periodic progress report of the coaching/training classes as prescribed in the sanction order to the Ministry of Minority Affairs and the State Government/UT administration.
- ii) The institute shall submit information of employment secured by the candidates coached/trained by them in Government and placements secured through their efforts in private sector to the Ministry of Minority Affairs and the State Government/UT administration.
- iii) The grantee institute will be open to inspection by the officers of Central Government/State Government/UT Administration.
- New component under the scheme from 2013-14 for focussed preparation of minority students at classes 11 & 12 with science (physics, chemistry, biology and/or mathematics).
 - i. Initially, during 2013-14 the new component of the scheme will be launched on pilot basis for about 900 students @ 100 or more students per Centre in 9 states/UTs, viz Uttar Pradesh, Bihar, Assam, West Bengal, Maharashtra, Karnataka, Tamilnadu, Punjab and Delhi. More States/UTs may be covered in later years as per scheme guidelines and availability of funds.
 - ii. The Ministry of Minority Affairs may advertise the details of the Scheme and invite proposal from the Schools/Colleges /Institutes having the facility of Hostel accommodation separately for Boys and Girls and running regular classes of XIth and XIIth with Science depending on the need for inclusion of more Schools/Colleges or States/UTs for this component from time to time.
- iii. The Institutes/Schools/ Colleges should be affiliated with CBSE/ICSE or State Education Boards to be eligible for this component. The physical verification of the Institute will be conducted by the Ministry.
- iv. Recommendation of the State Govt. /UT Administration

in respect of finally selected Institute/College/School will also be obtained only once. Subsequent inspection of the institute will be conducted by the Ministry

- v. Ministry may also conduct mid-term inspection.
- vi. The physical verification of the Institute will be conducted by the Ministry through an agency/ies, so selected by the Ministry from time to time.
- vii. The selection of students will be done by the selected Schools/Colleges/Institutes from students belonging to the notified minority communities on the basis of merit i.e % of marks or CGPA. The selection would be made starting from the highest % of marks or CGPA in the merit list for total number of students allotted to the selected Schoos/Colleges/Institutes. The students who are selected under this component must be willing to take entrance exams for Engineering Degree/Medical Degree after completion of this course.
- viii. The selection of Institutions/Schools/Colleges will be made by the Selection Committee consisting of the following:
 - a. Joint Secretary concerned of Ministry of Minority
 Affairs Chairperson
 - b. Director/Deputy Secretary (Finance) Members
 - c. Representative from Ministry of HRD Members
 - d. Representative of UGC Members
 - e. Representative from Education Institutions Co-opt Member
 - f. Director/Deputy Secretary of Ministry of Minority Affairs Convener
- ix. The selection of students will be done by the selected Institutes/Schools/Colleges from students belonging to the notified minority communities. The students will be selected by the concerned Institutes/Schools/Colleges on merit. Merit list will be prepared from eligible students of notified minority communities on the basis of merit (%

of marks or CGPA). The selection would be made starting from the highest % of marks or CGPA from the merit list, and, in any case, the students shall not be selected below 76% of marks or equivalent grade subject to total number of allotted students. The students who are selected for focused coaching must be willing to undergo Engineering Degree/Medical Degree after completion of course.

- x. The rate of financial support for a selected student under this Component is up to Rs. 1,00,000/- (Rs. one lakh only) per annum which is payable to the Institute.
- xi. The Outcome/Success Rate should not be less than 30% in case of allocation of students up to 100, 40% in case of allocation of students up to 200 under New Component of this Scheme. In case the stipulated Success Rate is not achieved, the amount of the last Installment payable to the Institute would be reduced proportionate to the percentage of deficiency in the outcome/success rate as penalty.

10. Minor modification without any financial implication:

Minor modification in the Scheme without any financial implication may be effected by the Ministry without seeking recourse to SFC/EFC.

11. Evaluation

The Scheme will be evaluated by an independent agency to assess its impact after the end of XII Five Year Plan.

Chapter 5a

FAQs Of Free coaching and Allied Scheme

Q1: Which are the Minority Communities eligible for this Scholarship?

Ans: Minority Communities notified under section 2(c) of NCM Act, 1992 are eligible for this Scholarship Scheme. They are: Muslims, Christians, Sikhs, Buddhists, Parsis (Zoroastrians), Jains.

Q 2: Who can apply for free Coaching/Training?

Ans: Students/Candidates belonging to minority communities can apply for free coaching/training in response to the advertisement published by the Coaching Institutes selected under this Scheme.

Q.3: What are the eligibility criteria?

Ans: The annual income of the student/parent or guardian of student should not exceed Rs.3.00 lakh from all sources and candidates must have secured the requisite percentage of marks in the qualifying examination prescribed for admission into the desired courses/recruitment examinations.

Q. 4: What are the courses for which free Coaching/Training is provided for?

Ans: Free Coaching/Training is provided by the Coaching Institutes selected under this **Sche**me for the following as approved by the Ministry of Minority Affairs:-

- a) Qualifying examinations for admission in technical/ professional courses such as Engineering, Law, Medical, Management, Information Technology etc. and Language/aptitude examinations for seeking admission to Foreign Universities.
- b) Competitive examinations for recruitment to Group 'A', 'B' and 'C' services and other equivalent Posts under the

Central and State governments including Public Sector Undertakings, Railways, Banks, Insurance Companies as well as Autonomous Bodies

A CONTINE CONCINING

Coaching/training for jobs in the Private Sector such as in Airlines, Shipping, Fisheries, Information Technology (IT), Business Process Outsourcing (BPO) and other IT enabled services, Hospitality, Tours and Travels, Maritime, Food processing, Retail, Sales and Marketing, Bio-technology and other job oriented courses as per the emerging trend of employment.

Q 5. What are the coaching and training courses normally approved under the scheme?

Ans: The following types of Coaching Courses/Training Programmes are normally approved under the Scheme:-

- i) Coaching for various entrance examinations for admission into Technical and Professional Courses such as Engineering, Medical, B.Ed, Law, MBA, C.A., DIET etc.
- UPSC/State Public Service Commission/SSC/State Subordinate Services/Railways etc. for Govt. jobs for Group A, B & C services including Civil Services and PCS.
- iii) Competitive Examinations for Bank/LIC/Other PSUs for jobs in Public Sector.
- iv) Trainings in various fields such as IT/ITES including BPO/various Computer Courses/Sales & Retail Management, Accounting etc. for jobs in Private Sector.
- Other specialized trainings which has the potential to fetch a job in Govt. or Private Sector.

Q. 6: How is the Scheme implemented?

Ans: The Scheme is implemented through the Coaching/Training Institutes run by the following:-

i) All institutes in the Government Sector, including Universities and Autonomous Bodies, engaged in Coaching/Training activities.

- ii) Universities/Colleges in Private Sector engaged in Coaching/Training activities, including Deemed Universities.
- iii) Institutes in the Private Sector engaged in Coaching activities/job oriented Coaching/Training for placement in Private Sectors, which are a Trusts, Companies, Partnership Firms, or Societies Registered under the relevant law, preferably of relevant industry bodies or Institutes identified by them.

Q 7: What is the rate of coaching fee & stipend?

Ans: Coaching fee is admissible to the Coaching/Training Institutes keeping in view the rates prevailing in the locality for the particular Coaching/Training Programme subject to the maximum limit as mentioned below. The rate of stipend for local and outstation candidates are also mentioned against each Coaching/Training Programme.

Chapter 6

Scheme Of Support for Clearing Prelims Conducted by UPSC, SSC, SPSC

Background and Justification of the Scheme:

National Commission on Religious and Linguistic Minorities in its report has highlighted that all communities and groups should have equal share in economic opportunities and employment. It envisages proactive measures for those communities that lag behind and become increasingly marginalized. Hence interventions in the form of Government programs need to help these communities, with earmarking of targets on (1) Self- employment and Wage employment and (2) Recruitment to State and Central Services.

An exclusive scheme was launched during the 11th Five Year Plan Period to provide pre-examination coaching for competitive examinations in government and private institutions for candidates from minority communities.

The representation of the Minority Communities in the Civil Services continue to be lower compared to the ratio of their population.

Recruitment of minority candidates as reported by Ministry of Personnel, Public Grievance and Pensions, Department of Personnel and Training (DoPT) was, 8.23%; 9.90%; 7.28% and 11.9 % in 2007-08;2008-09; 2009-10; and 2010-11 respectively. This calls for policy intervention in the form of special support for minorities to clear the competitive Civil Services Examinations.

Objectives

The objective of the Scheme is to provide financial support to the minority candidates clearing prelims conducted by Union Public Service Commission, Staff Selection Commission and State Public Service Commissions to adequately equip them to compete for appointment to Civil Services in the Union and the State Governments and to increase the representation of the minority in the Civil Services by giving direct financial support to candidates clearing Preliminary Examination of Group A and B

(Gazetted and non-Gazetted posts of Union Public Service Commission (UPSC); State Public Service Commissions (SPSCs) and Staff Selection Commission (SSC) etc.

Implementing Agency and Eligibility: Ministry of Minority Affairs will be the implementing agency and only candidates belonging to notified Minority Communities who clear the Prelim examinations conducted by UPSC; SPSC or SSC etc. and fulfill all other eligibility criteria and conditions will be considered for financial support under the scheme. Eligibility criteria and conditions of the Scheme will be as follows:

1. The candidate should belong to one of the Minority Communities notified under Section 2 (C) of National Commission for Minorities Act, 1992 and should have passed the Prelims Examination conducted by UPSC; SPSC or SSC etc.

II. Total family income of the candidates from all sources should not

exceed Rs. 4.5 lakh per annum*.

III. The financial support can be availed by a candidate only once. The candidate will not be eligible to benefit from any other similar Scheme of the Central or State Governments /UT Administrations. In case the candidate decides to opt for other Schemes; he/she will have to forgo the claim from this Ministry and refund the amount if already availed with 10% interest. He / she needs to give an affidavit to the effect, that he /she is not availing such benefit from any other source.

Note*: Income from all sources which has been projected as Rs. 4.5 lakh in para 3 (ii) above is subject to change with change in creamy layer exemption/ceiling over the 12th plan period and beyond.

Procedure:

Every year Ministry of Minority Affairs will advertise for inviting applications from eligible candidates through News Papers and on its website. Eligible candidates will apply to this Ministry on the pro forma developed for this purpose under the Scheme.

4. Cost/Number of Beneficiaries:

Every year up to a maximum of 800 candidates will be given financial support under the scheme throughout the country on fulfilling the eligibility criteria till the budgetary allocation is exhausted. Selection of the candidates will be based on merit in case of limited number of

slots available for any particular community. Till the Census of 2011 is available the Ministry will use the figures of 2001 Census. The physical distribution of benefits to different notified minority communities will be as follows:

Muslims: 584; Christians: 96; Sikhs: 80; Buddhists: 32; Parsis: 8.

The rate of financial assistance will be maximum Rs. thousand(Rs. 50,000/- for Gazetted Post; and Rs 25,000/- for Non-Gazetted Post) only as support to the minority candidates who have cleared the Prelims conducted by Union Public Service Commissions; Staff Selection Commissions or State Public Service Commissions etc for Group 'A' and 'B' Civil Services.

5. Terms and Conditions for Candidates

- The candidate should submit the proof of passing of i. preliminary examination conducted by Union Public Services Commission, State Public Services Commission, Staff Selection Commission etc. or equal examination for Group 'A' and 'B'(Gazetted and Non Gazetted) Civil Services. This consists of Roll Number slip, Identity Card and Result.
- The candidate should submit the proof of income of the family ii. from the all sources. The annual Income Certificate should be issued by a Competent Authority as may deem fit by State Government/UT Administration. The candidate should submit Affidavit / Certificate for community proof to be issued by the Competent Authority.

Funding Pattern:

100% financial support will be provided to the selected candidates through a Nationalized Bank as this is a Central Sector Scheme (CSS). Payment will be through ECS/RTGS/Cheque/e-payment Aadhar number will be mandatory for candidates coming from 121 DBT Districts presently. In consequent years Aadhar number will be mandatory for all candidates seeking support under this Scheme.

- 6. Procedure on the receiving the proposals/applications under the scheme. The following committee will evaluate and select the applicants for grants-in-aid under the scheme:
 - A. Secretary (Minority Affairs) Chairperson
 - B. Financial Advisor (Minority Affairs)
 - C. or his/her representative Member
 - D. Joint Secretary(SS)(Minority Affairs) Member
 - E. Representative from DoPT
 - F. not below the rank of Director;
 - G. Representative from Ministry of HRD not below the rank of Director; Member
 - H. Representative from Ministry of Labour not below the rank of Director; Member
 - Representative from UGC not below the rank of Director; Member
 - J. Deputy Secretary/Director (SS) (Minority Affairs) Convener

7. Monitoring and Evaluation Mechanism:

A monitoring mechanism would be put in place to see that there is timely disbursal of amount through the concerned banks so that the selected students do not suffer due to delay. Evaluation of the scheme will be taken up after 3 years of its implementation through an independent and specialized agency. Impact assessment will be conducted towards the end of the 12th Plan Period.

Chapter 7

Scheme Of Maulana Azad National **Fellowship**

To be implemented by : UGC

: Minority Community Student would How to Apply

Apply online or otherwise to the UGC in response to the advertisement published in the Newspaper's, internet & Web page

UGC.

Objective

1. The objective of the Fellowship is to provide integrated five year fellowships in the form of financial assistance to students from minority communities, as notified by the Central Government to pursue higher studies such as M. Phil and Ph.D. The Fellowship will cover all Universities/Institutions recognized by the University Grants Commission (UGC) under section 2(f) and section 3 of the UGC Act and will be implemented by the Ministry of Minority Affairs through UGC for students belonging to the minority communities. The fellowship under Maulana Azad National Fellowship for minority students will be on the pattern of UGC Fellowships awarded to research students pursuing regular and full time M. Phil and Ph.D courses. The fellowship holders under this Fellowship will be known as Ministry of Minority Affairs scholars.

Scope of the Fellowship

The Fellowship will cater to the requirements of the minority community students pursuing research studies leading to regular 2. and full time M.Phil and Ph.D courses only and equivalent research degree in universities, research institutions and scientific institutions within India. This will enable them to be eligible for employment to the posts with M.Phil and Ph.D as pre-requisites, including the posts of lecturers in various academic institutions.

Implementing Agency

UGC will be the nodal agency for implementing the Fellowship.
 UGC will notify the Fellowship by releasing suitable advertisement in the newspapers, internet, webpage & other media.

Eligibility

- A candidate has to fulfill the following conditions to be eligible for award of this fellowship:-
 - He/she should belong to one of the minority communities notified under Section 2 (c) of the National Commission for Minorities Act, 1992.
 - ii. He/she should get admission and registration for regular and full time M.Phil/Ph.D courses in University/Academic Institution by fulfilling conditions of admission of that University/Institution, subject to provisions of the Fellowship as per advertisement of UGC.
 - iii. The minority community students once considered eligible for the fellowship shall not be entitled to benefits under any other source, Central or State Government or any other body like UGC for the same study.
 - iv. Prior clearance of NET/SLET examination will not be a prerequisite for award of Maulana Azad National Fellowship for minority students for M. Phil/Ph.D.
 - v. In order to qualify for the award of JRF/ SRF the UGC norms would be applicable at pre-M.Phil and pre-Ph.D stage, respectively, including the minimum score of 50% at post graduate level

Distribution of Fellowships

- i. The total number of fellowships each year will be 756 (state wise distribution is at annexure). In case of non-availability of adequate number of candidates, the number of fellowships not availed during a year will be carried forward to the next academic session
 - ii. 30% of the fellowship shall be earmarked for women students;

- Benefits
- remaining 70% will be general. In case there are shortage of women candidates, the fellowship can be passed on to male students of the same minority community.
- iii. Other factors remaining the same, preference will be given to the candidates who deal with research themes/ topics in areas pertaining to linguistic minorities, dialects / languages of linguistic minorities, protection of languages facing extinction as brought out by UNESCO, and promotion of scripts for script-less languages of linguistic minorities
- iv. In case the numbers of candidates exceed the number of available awards, UGC will select the candidates for the fellowships based on the percentage of marks obtained by them in their qualifying Post Graduation examination.
- v. The reservation for differently-abled students shall be made as per UGC norms and in a horizontal manner.
- vi. The fellowships will be operated on the basis of a roster which will be as follows: First: Arts, Second: Commerce, Third: Sciences, Fourth: Engineering and thus on.

Duration of Fellowship:

6. These are integrated five year fellowships for M.Phil & Ph.D subject to academic criteria in force for selection to Ph.D programme. The duration of fellowship is as under:

In additional for physically/ visually escorts/reader assistance will be given @ Rs. 2,000 p.m. HRA and other incidentals will be paid as per the UGC pattern.

Implementation of Maulana Azad National Fellowship for minority students:

procedure is indicated as under:

- (i) UGC will be the nodal agency for implementing the Maulana Azad National Fellowship for minority students, as defined by Government of India from time to time.
- (ii) UGC will notify the fellowship by inserting suitable advertisement in the Press and other media.

(iii) UGC will be implementing the fellowship from the academic year i.e., 2009-10

(iv) Clearing NET/SLET shall not be insisted upon by UGC for the award of Maulana Abul National Fellowship for minority students... UGC will give adequate time to the candidates for applying for the fellowship.

(v) UGC will select the candidates for award of Maulana Azad National Fellowship for minority students in a transparent manner.

- (vi) In case the numbers of candidates exceed the number of available awards, the UGC will select the candidates based on the percentage of marks obtained by the candidates in their Post Graduation Examination.
- (vii) The distribution of fellowship among different States/UTs would be in proportion to minority population in respective States/UTs as per 2001 census. However, all States/UTs shall have at least 4 fellowships (one under each roster point) by suitably reducing the targets of states having higher allocations. There will be no community-wise distribution in States/UTs with four fellowships. All applications will be pooled together and decided on the basis of merit.

(viii) In case the number of fellowship so allocated to a State/UT are not fully utilised, due to non-availability of eligible candidates, UGC will reallocate the slots amongst other States/UTs where the number of eligible candidates is more than the slots allocated to that State/UT. This decision will be taken by a Committee consisting of the representatives of UGC and Joint Secretary incharge of the scholarship in Ministry of Minority Affairs

(ix) UGC shall disburse the fellowship amount to the candidates through electronic clearance system (ECS) wherever feasible.

(x) UGC will also issue a booklet containing all the details about the fellowship for the benefit of prospective candidates, and upload the details of the Fellowship in its webpage with appropriate

reference to Ministry of Minority Affairs. To the extent possible e-application will be actively promoted by UGC.

*In addition, for physically /visually handicapped candidates UGC (xi) will evolve its own mechanism for verifying the genuineness of the minority community certificates furnished by the candidates in order to eliminate the possibility of students availing of the fellowship on the basis of fake certificates.

(xii) The decision of UGC in regard to awarding the Maulana Azad National Fellowship for minority students shall be final and no appeal would lie against any decision by UGC in regard thereof,

except as provided under law in force

(xiii) Fellowship cannot be transferred from one minority community to another.

(xiv) The income ceiling of the parents/guardian of the candidate for Maulana Azad National Fellowship for minority students will be Rs.2.5 Lakh per annum.

(xv) Selection of candidates, within the prescribed annual income limit will be based on inter-se merit, as under Merit-cum-Means Scholarship Fellowship

(xvi) In case any candidate obtaining a Maulana Azad National Fellowship for minority students fraudulently, the cancellation should be automatic and the amount disbursed shall be recovered with interest at prevailing State Bank of India rate for student loans.

Administrative Expenses:

10. Administrative charges will be paid by Ministry of Minority Affairs to UGC for implementation of the fellowship at the rate given by M/o

Monitoring and Evaluation

- 11. UGC shall assess the work on completion of two years' period of the JRF and two years' period of S . The research work being done by the students shall be monitored as provided under UGC Rules.
- 12. UGC will send a quarterly physical and financial progress report to Ministry of Minority Affairs and provide a list of Maulana Azad National Fellowship for minority students, university, minority community & State/UT-wise, for Ministry's information and follow-up actions, if any, apart from displaying the same in its website.

- 13. Fellows who cannot complete M.Phil in 2 years time or are found ineligible to register in the Ph.D programme during the 3rd year will be discontinued forthwith.
- 14. Income certificates will be issued by the competent authority as notified by the State/UT Governments.
- 15. The Minority Community certificate, until issued by designated authorities in the States and UTs, should be based on an actionable and legally valid affidavit so that no candidate avails a scholarship through falsification of one's community status.

Modification of the Fellowship

16. Ministry of Minority Affairs can make minor modifications in the fellowship, with the approval of the Hon'ble Minister of Minority Affairs, with no significant financial implication, if it comes across developments that necessitate some changes while implementing the fellowship and in the interest of smooth implementation of the fellowship.

Note: The following table shows the number of Fellowships availed of by minority communities, State-wise and Community-Wise. Since the Jain community was accorded the national Minority status only in January 2014, this table does not have the name of the Jain community. Members of the Jain community desiring to apply of these Fellowships may do so henceforth.





Chapter 8

Scheme of Interest Subsidy on Educational Loans for Overseas Studies - Padho Pardesh

- 1. Background: The Prime Minister's New 15 Point Programme for the Welfare of Minorities was announced in June, 2006. It provides that the schemes for scholarships for meritorious students from minority communities will be formulated and implemented. The scheme of Interest Subsidy on educational loans for overseas studies will promote educational advancement of student from minority communities.
- 2. Objective: The objective of the scheme is to award interest subsidy to meritorious students belonging to economically weaker sections of notified minority communities so as to provide them better opportunities for higher education abroad and enhance their employability.
- 3. Scope: This is a Central Sector Scheme to provide interest subsidy to the student belonging to the communities declared as minority communities in terms of section 2 (c) of National Commission for Minorities Act, 1992, on the interest payable for the period of moratorium for the Education Loans under the Scheme of Interest subsidy on Educational Loans for Overseas Studies to pursue approved courses of studies abroad at Masters and Ph.D levels.

4. Conditions for Interest Subsidy:

- I. The Scheme is applicable for higher studies abroad. The interest Subsidy shall be linked with the existing Educational Loan Scheme of Indian Bank's Association (IBA) and restricted to students enrolled for course at Masters, M. Phil and Ph.D levels.
- II. The interest subsidy under the scheme shall be available to the eligible students only once, either for Masters of Ph. D levels. Interest subsidy shall not be available to those students who either discounted the course mid-

Benefits of Minority for Student stream, due to any reason, or those who are expelled from the institutions on disciplinary or academic grounds.

- The benefit of 1% interest reduction in the interest rate offered by Banks in normal course on Pre-Payment of interest during the moratorium period shall be passed on to the students.
- IV. If a student violates any conditions of the scheme, the subsidy will be discounted forthwith.
- v. If a student is found to have obtained the subsidy by false statement / certificates, the subsidy will be withdrawn/ cancelled forthwith and amount of subsidy paid shall be recovered with panel interest, apart from taking criminal action as per law.
- VI. The students obtaining benefits under this Scheme shall not be given the interest subsidy if he gives up Indian citizenship during the tenure of the loan.
- The designated back will maintained a separate account VII. and records relating to the funds received from the ministry and these will be subject to inspection / audit by the officers of the Ministry, or any other agency designated by the Ministry and C & AG.
- The fund for interest subsidy from the 2nd year onwards VIII. will be released to the designated Bank after receiving the utilization certificate for the earlier releases as per provisions of GFR.
- The designated Bank shall place all relevant details of financial and physical achievements on its website and IX. implement the scheme as per the Memorandum of understanding to be signed between the designated Bank and Ministry of Minority Affairs.
- X. The designated Bank will ensure that the students from the minority communities, who may also belong to SC/ST / OBC category, do not avail interest subsidy from other sources for the same purpose.
 - The designated Bank will lay down the detail procedure for processing and sanctioning of interest subsidy to XI.

- eligible students in consultation with Ministry of Minority Affairs.
- XII. The scheme will be evaluated at regular intervals by the Ministry or any other agency designated by the Ministry and the cost of evaluation study will be borne by the Ministry.
 - XIII. The terms and conditions of the scheme can be changed at any time at the discretion of Ministry of Minority Affairs to improve procedure and achieve more effective implementation. However, these should not be financial implications.

5. Eligibility:

- 1. The student should have secured admission in the approved courses at Masters, M.Phil or Ph. D levels abroad for the courses shown at Para-14.
- II. He/she should availed loan from a scheduled bank under the Education Loan Scheme of the Indian Banks Association (IBA) for the purpose.

6. Income Ceiling

- I. Total income from all sources of the employed candidate or his/her parents/guardians in case of unemployed candidate shall not exceed Rs. 6.00 lakh per annum.
- II. Income certificate should be submitted from the competent authority in the State / Union Territory.

7. Recommendatory Committee:

- I. Recommendatory Committee headed by Joint Secretary in-charge of the Scheme with representatives of Finance Division, representative of Nodal Bank and concerned Director/Deputy Secretary as convener will examine and recommend the applications for award of interest subsidy on quarterly basis.
- II. To the extent possible, the benefit of Interest Subsidy will be given to notified minority communities in the ratio of their population.
 - III. Preference will be given to the girl candidates.

Rate of Interest Subsidy :

- Under the scheme, interest payable by the students availing of the education loans of the IBA for the period of moratorium (i.e. course period, plus one year or six months after getting job, whichever is earlier) as prescribed under the Education Loan Scheme of the IBA, shall be borne by the Government of India.
- After the period of moratorium is over, the interest on the outstanding loan amount shall be paid by the student, in accordance with the existing Educational loan scheme may be amended from time to time.
 - III. The Candidate will bear the principle installments and interest beyond moratorium period.

Implementing Agencies 9.

The scheme will be implemented by the designated bank as per MoU between the Bank and Ministry of Minority Affairs.

Administrative Expenses 10.

- A provision not exceeding 3% of the annual budget allocation for the scheme will be made to meet the administrative and allied costs viz. expenditure of the Ministry for office equipments including computer and accessories, advertisements, engagement of personnel, etc.
- This provision will also be used for evolution and monitoring of the scheme, thought outside reputed 11. institutions/agencies engaged by the ministry of minority Affairs, Government of India. Administrative cost of the Bank will be shared as per provision in the MoU.

Monitoring & Transparency 11.

- The Ministry of Minority Affairs shall monitor the i) performance of the scheme.
- For this purpose, a web enabled monitoring mechanism shall be put in place by designated Bank. ii)

- iii) The Designated Nodal Bank will be required to furnished quarterly financial and physical progress reports to the Ministry.
 - iv) The Designated Nodal Bank shall maintain in year-wise details of the students receiving scholarship, indicating institute, location of the institute, class, gender, new or renewal, permanent address and parents address.
 - v) Designated Nodal Bank shall place relevant physical and financial details on their Official website.

12. Minor Modification/Changes

Minor Modification/Changes in the scheme with no financial implications may be made by the Competent Authority without seeking recourse to SFC/EFC/Cabinet.

13. Evaluation

The monitoring of the financial and physical performance of the scheme will be periodically evaluated by the assigning evaluation/impact studies to reputed institutions/agencies by the Ministry of Minority Affairs, Government of India.



भारतीय जैन संघठन (BJS) - एक परीचय

भारतीय जैन संघठन (BJS) यह समस्त जैन समाज का प्रतिनिधित्व करने वाली एक सामाजिक संस्था है। जिसकी स्थापना इसके संस्थापक पूना निवासी श्री. शांतिलालजी मुख्या ने १९८५ में की। यह संस्था सामाजिक उत्थान, शैक्षणिक विकास तथा आपदा प्रबंधन क्षेत्र में कार्य कर रही है।

BJS मुख्य रूप से राष्ट्रीय समस्याओं पर अपना लक्ष केन्द्रित कर उनके निवारण हेतु गहराईसे अध्य्यन कर समाधान प्रस्तुत करने का कार्य तीन दशक से कर रहा है।

BJS में राष्ट्रीय कार्यकारिणी से लगाकर शहर/गांव कार्यकारिणी की शृंखला स्थापित है। संस्था में पदाधिकारीयों का चयन चुनाव पध्दित से ना होकर मनोनयन पध्दित से होता है। पदाधिकारियों को मनोनित करने का संम्पूर्ण अधिकार संस्थापक व राष्ट्रीय अध्यक्ष को है। यह कार्य वरिष्ठ पदाधिकारियों की सलाह से किया जाता है।

वर्तमान में BJS का कार्यक्षेत्र देश के लगभग २० राज्यों में है। संस्था में हजारो पदाधिकारी एवं कार्यकर्ता समर्पण भाव से समाज उत्थान के कार्य में लगभग ५०० प्रोफेशनल लोग रिसर्च के माध्यम से समाज उपयोगी समाधान के मॉडल्स एवं कार्यक्रम तैयार करने का कार्य बड़ी कुशलतापूर्वक कर रहे हैं। सामाजिक उत्थान, शैक्षणिक विकास व आपदा प्रबंधन के क्षेत्र में पिछले तीन दशक में किये गये विशेष कार्य की जानकारी निम्नलिखित है। आपसे विनम्र निवेदन है कि, BJS के कार्यों से जुडकर देश मिर्माण में अपना योगदान दे।

सामाजिक उत्थान

समय काफी तेजीसे बदल रहा है। २५-३० वर्षों में बदलाव की जो रफतार रही है, वह पिछले १००-२०० वर्षों में भी अनुभव करने को नहीं मिली। तेजीसे बदलते हुए इस युग में 'परिवार' यह अवधारणा बिखर रही है, तथा इसे बांधे रखने का कार्य अत्याधिक कठीन होता जा रहा है। परिवार ही नहीं बचेंगे, तो समाज का अस्तित्व कैसे रहेगा? इस गंभीर समस्यापर BJS ने, परिवार में रहनेवाले प्रत्येक सदस्य की जरूरतों को समझकर, गहराईसे अध्ययन कर निम्नलिखित समाधान प्रस्तूत किये है।

छात्र मूल्यांकन कार्यक्रमं कक्षा ४थी एवं ८वी के विद्यार्थीयों के लिए

(Student Assessment Program - SAP 4th & 8th)

तीन घंटे की इस जांच परिक्षा के लिए किसी भी प्रकार की पूर्व तैयारी की आवश्यकता नहीं है। विद्यार्थी बडे मजे से, खेल खेल में इस जांच परिक्षा में सहभाग लेते है, तथा बडी सहजता से पालकों को अपने बच्चों की भावनात्मक, मानसिक, सामाजिक योग्यता व सामान्यज्ञान, स्वास्थ्य, संबंधित विषयों पर जानकारी प्राप्त होती है। बीजेएस द्वारा, इस कार्यक्रम के माध्यम से, विद्यार्थीयों की क्षमता एवं योग्यता का आकलन कर, उन्हें अपनी रूचि अनुसार, शिक्षा के क्षेत्र में, प्राविण्यता प्राप्त करने के उद्देश्य से, पालकों का विशेष मार्गदर्शन किया जाता है। SAP 4 अब Online www.bjssap.org पर भी उपलब्ध है।

कैरियर मार्गदर्शन कार्यक्रम (Carrier Guidance Program)

स्पर्धा के इस युग में, दसवी तथा बारहवी के पश्चात विद्यार्थीयों ने कौन से शैक्षणिक क्षेत्र का चयन करना चाहिए, कौन कौन से क्षेत्र भविष्य की शिक्षा के लिए उपलब्ध है, कौन से कॉलेजों का चयन करना चाहिए, उनमें प्रवेश प्राप्त करने की क्या प्रणाली है, पिछले वर्ष का कट ऑफ प्रतिशत क्या था, इत्यादि अनेक प्रश्नों का सामना करना पडता है। इस विषय में, जानकारी के अभाव की वजह से, ना ही माता-पिता मदद कर पाते है और ना ही स्कूल मदद कर पाता है। आज के दौर में विद्यार्थीयों को योग्य कैरियर मार्गेदर्शन की अत्याधिक आवश्यकता है। BJS अपने एक्सपर्ट कैरियर मार्गदर्शकों के माध्यम से परिवार की इस जरूरत की पूर्ती हेतू विद्यार्थी एवं पालकों के लिए कैरियर मार्गदर्शन के वर्कशॉप आयोजित करता है।

युवतियों का सक्षमीकरण'- २१ वी सदी की सामाजिक चुनौतियो का सामना करने हेतु Empowerment of Girls to face the social challenges of 21st century (EoG)

आज के इस दौर में, स्कूली शिक्षा पूर्ण कर, उच्च शिक्षा हेतु कॉलेज में प्रवेश करनेवाली, सोलह से पचीस वर्ष की युवितयों के समक्ष अनेक कठिनाईयाँ, आग के समान विक्राल रूप धारण किये खड़ी है। जैसे की

अपनेही परिवार में कैसे जीना, माता-पिता से संवाद कैसे करना, नए एवं अच्छे मित्रों का चयन कैसे करना, अपने आत्मविश्वास को टिकाये कैसे रखना, मिडीया-मोबाईल-इंटरनेट के दुष्परिणाम से कैसे बचना, व्यक्तिगत सुरक्षा का ध्यान कैसे रखना, पारंपरिक विवाह व प्रेम विवाह के गुण एवं दोष का पूर्व आकलन कैसे करना, इत्यादि अनेक प्रकार की आग आज जमाने में लगी है। इस आग को हम बुझा सकते नहीं। लेकिन इसका सामना करने के लिए युवतियों को प्रशिक्षण के माध्यम से फायर फायटर जरूर बना सकते है। यह अत्याधिक महत्त्वपूर्ण कार्य है। BJS ने अपने तीन दशक के सामाजिक अनुभव के आधार पर, युवतियों को सक्षम करने हेतु, एक्सपर्ट के माध्यम से तीन दिवसीय कार्यशाला तैयार की है। यह कार्यशाला युवतियों को सुरक्षा कवच प्रदान कर, इस सदी की सामाजिक चुनीतियों का सामना करने हेतु सक्षम बनाती है। इस कार्यक्रम के द्वारा ११ राज्यों में १०,००० से अधिक युवतियों का सक्षमीकरण किया गया है। EoG अब Online (www.eogonline.org) पर भी उपलब्ध है।

युवक-युवती परिचय संमेलन (Matrimonial Meet)

योग्य जीवन साथी की तलाश सभी परिवारों की है। परिवार कितनाही समृध्द क्यों न हो, शिक्षित क्यों न हो, नामी क्यों न हो, योग्य रिश्तों की कमी सभी को है। दूँढने पर भी योग्य रिश्ते मिल नहीं पाते। नजदीक के रिश्तेदार भी, ना ही रिश्तों की जानकारी देते है और ना ही रिश्तों के बीच में पडते है। रिश्ते ठीक से मिलेंगे नहीं तो जुडेंगे कैसे? रिश्ते ठीक से जुडेंगे नहीं तो टिकेंगे कैसे? रिश्ते ठीक से टिकेंगे नहीं तो परिवार आगे बढेंगे कैसे? BJS ने सन १९८५ में इस समस्या को समझा, गहराईसे अध्ययन किया तथा 'परिचय संमेलन' विकल्प के रूप में समाज के समक्ष प्रस्तूत किया। एक ही दिन में, एक ही स्थान पर, अपने बेटे या बेटी के लिए, पचास-सौं रिश्तें उपलब्ध करवाने का मंच है, 'परिचय संमेलन'। समाज की जरूरतों को समझते हुए विभिन्न प्रकार के परिचय संमेलन आयोजित किये जाते है। जैसे की, प्रोफेशलन परिचय संमेलन, उच्च शिक्षित परिचय संमेलन, सामान्य शिक्षित परिचय संमेलन, शहरी परिचय संमेलन, ग्रामीण परिचय संमेलन, पुर्नविवाह हेतु परिचय संमेलन। पिछले तीन दशक में इन परिचय संमेलनों को अत्याधिक प्रतिसाद मिला है। तथा रिश्ते तय करने में परिचय संमेलन वरदान साबित हुए है।

नव विवाहितों का सक्षमीकरण - सुखी घर प**रिवार के लिए Empower**ment of Couples for Happy Family & Happy Home (EoC)

आज के जमाने में रिश्तें तय होने जितने कठिन है, उससे ज्यादा किन है, रिश्ते निभाना। छोटी छोटी बातों पर बडी बडी खटपट होने लगी है। खान-पान, रहन-सहन, बोल-चाल, पहनावा आदि में अत्याधिक बदलाव आये है। जीने के तौर तरिके बदल गए है। पति - पत्नी दोनों ही शिक्षित, उच्चशिक्षित है। करियर ने घरेलू कामकाज के ऊपर प्राथमिकता ले ली है। धैर्य, समर्पण विश्वास, सामंजस्य, सुसंवाद आदि में काफी कमी आयी है, वहीं अहंकार अत्याधिक बढ गया है। यही सब वजह है, रिश्तों में दरार की व परिवारों में बिखराव की। भारतीय जैन संघठन के संस्थापक, दूरदृष्टा श्री. शांतीलालजी मुथ्था ने सन २०१० मे जैन समाज के राष्ट्रीय अधिवेशन में घोषणा की, कि आनेवाले दस-पंद्रह वर्षों में हर दो विवाह में से एक विवाह टुटेंगा अगर सह में ऐसा होता है, तो यह समाज के अस्तित्व के लिए अत्याधिक हानिकारक होगा। इस बात को ध्यान में रखकर BJS ने नवविवाहीतों (विवाह के उन वर्ष तक) में आपसी सौहार्द एवं सामंजस्य स्थापित रहने के दृष्टिकोन से दा दिवसीय कार्यशाला तैयार की है। इस दो दिवसीय कार्यशाला के माध्यम स नव विवाहित जोडो तथा उनके पालको के आपसी सम्बंधो में सामंजस्य बेहतर संवाद, संगठित एंव संयुक्त रहने की भावना, एक दूसरे का विशेष ध्यान, देखभाल, त्याग एंव समर्पण भाव के साथ वैवाहिक और परिवारिक दायित्व एंव सम्बंधों की विकसित करने हेत् प्रशिक्षण दिया जाता है।

व्यवसाय वृद्धि कार्यक्रम (Business Development Program)

परिवर्तन के इस युग में पारंपारिक व्यवसायों मे नई पिढी की घटती रूची, पुराने व्यवसायों के अस्तित्व का प्रश्न, मॉल संस्कृती का प्रभाव, व्यवसाय की नई संभावना के प्रति दुर्लक्ष, नई पिढी के कार्यक्षमता का पूरा उपयोग ना होना आदि बातों की वजह से व्यवसाय मे अपेक्षित प्रगति नहीं हो पा रही है। BJS अपने एक्सपर्ट प्रोफेशनल मार्गदर्शकों के माध्यम से नये एवं पुराने व्यवसायियों के लिए Business & Entrepreneurship Development Program द्वारा मार्गदर्शन करता है।

व्लॅस्टिक सर्जरी (Plastic Surgery)

BJS सन १९९० से लगातार, छोटे बच्चों के कटे फटे ओंठ, (Cleft leaf) पलक एवं नाक और कान की बाह्य विकृती, चेहरे के दाग आदि का उपचार निशुल्क प्लॅस्टिक सर्जरी के द्वारा, अमेरिका के एक्सपर्ट डॉक्टर की टीम के माध्यम से कर रहा है। अब तक दो लाख पचास हजार से ज्यादा निश्लक प्लॅस्टिक सर्जरी BJS द्वारा की गई है।

अल्पसंख्यक सम्बंधित जानकारी (Minority Cell)

२७ जनवरी २०१४ को भारत सरकार ने जैन समाज को राष्ट्रीय स्तर पर अल्पसंख्यक का दर्जा प्रदान किया। अब तक मुस्लिम, बौध्द, स्त्रिश्चन, सिख एवं पारसी धर्मों को अल्पसंख्यक दर्जा प्राप्त था। भारत सरकार द्वारा अल्पसंख्यक समाज के उत्थान की अनेक योजनाओं के लिए प्रति वर्ष करोड़ों रूपये का प्रावधान बजट में किया जाता है। जैन समाज के विद्यार्थियों कि शिक्षा एवं छात्रवृत्ति कि विविध योजनाए, शैक्षणिक संस्थाओं कि स्थापना एवं प्रशासन की विविध योजनाएँ, युवितयाँ एवं महिलाओं के सक्षमीकरण की योजनाएँ, व्यवसाय के विकास की विभिन्न योजनाए, धर्मस्थान की सुरक्षा की विभिन्न योजनाए एवं स्वयंसेवी संस्थाओं के माध्यम से समाज उत्थान की विविध योजनाए उपलब्ध है।

देश में कॉलेजों की गुणवत्ता का विकास करने की दृष्टिकोन से सरकार ने १९९४ में National Assessment & Accrediation Council (NAAC) का गठन किया। लेकिन ऐसी कोई योजना स्कूलों के लिए उपलब्ध नहीं है। इगड़ ने सन २००४ में स्कूलों के ऑसेसमेंट और ऑक्रेडिटेशन का कार्यक्रम तैयार कर देश की चार हजार से अधिक सरकारी एवं प्रायव्हेट स्कूलों में क्रियान्वित किया। यह कार्यक्रम उपचारात्मक पध्दित का कार्यक्रम है। निर्धारित संकेतको व मानको के आधार पर स्कूल की प्रक्रिया का मूल्यांकन करता है। सुधार के आवश्यक क्षेत्रों का पता लगाता है। स्कूल के मुख्याध्यापक एवं प्रबंध समिति को विशेष सुधार की क्रियाओं से अवगत कराता है। जिससे स्कूल की प्रक्रिया में गुणात्मक सुधार लाया जा सकता है।

भारतीय जैन संघठन ने यह स्कूल ॲसेसमेंट ॲन्ड ॲक्रेडिटेशन कार्यक्रम विभिन्न राज्य सरकारों के लिए उपलब्ध किये है। जिसके माध्यम से उन राज्यों की सरकारी एवं प्रायव्हेट स्कूलों में गुणवत्ता विकास होने में सिविधा मिलेगी। भावी पिढी को मुल्यआधारित गुणवत्तायुक्त शिक्षण द्वारा तैयार कर सशक्त देश निर्माण के स्वप्न को पूर्ण करने का लक्ष है। मूल्यवर्धन (Value Education Program)

संस्कृती प्रधान इस देश में मूल्यों का पतन हो रहा है। आपसी भाईचारा, एक दुसरे के प्रति सौहार्द, सहिष्णुता, प्रामाणिकता आदि गुण कम होते जा रहे है। तथा इनकी जगह दुर्व्यसन, संवेदनहिनता, हिंसा आदि ने स्थान ले लिया है। भावी पिढी को गुणवत्ता आधारित शिक्षण के साथ साथ मूल्यआधारित शिक्षण भी देना आज की प्राथमिकता हो गई है। भारतीय जैन संघठन ने इस बात को ध्यान में रखकर सन २००९ में 'मूल्यवर्धन' नामक पाठ्यक्रम तैयार कर महाराष्ट्र के बीड जिले में सरकार की सहमती से ५०० स्कूल के ३५,000 बच्चों पर प्रयोगात्मक कार्य शुरु किया है। मूल्यवर्धन कार्यक्रम का विद्यार्थियों पर, उनके परिवारों पर, आसपास के क्षेत्र पर क्या परिणाम हो रहा है, यह जानने के लिए NCERT, Cambridge University (UK), Oregon University (USA) जैसी राष्ट्रीय एवं आतंरराष्ट्रीय संस्थाओं द्वारा Impact Assessment कराया गया, तथा इसके परिणाम उत्साहवर्धक है। विद्यार्थी केंद्रित यह पाठ्यक्रम देश की सभी स्कूलों के लिए आज उपलब्ध है। शैक्षणिक क्रांति करने की क्षमता जैन समाज में है। 93,00,000 स्कूलों में शिक्षा ग्रहण कर रहे विद्यार्थी देश का भविष्य है। इन्हीं स्कूलो के माध्यम से गुणवत्तायुक्त मूल्य आधारित शिक्षण इन विद्यार्थियों तक पहूँचाना ही भारतीय जैन संघठन का उद्देश है। सन २००५ में विश्व की सभी सामाजिक संस्थाओं के संघठन (World Association of Non Governmental Organization -WANGO) ने भारतीय जैन संघठन को शिक्षा के क्षेत्र में विश्व की सर्वोद्य स्वयंसेवी संस्था के रूप में सम्मानित किया।

आदिवासी समाज विकास कार्यक्रम (Tribal Project)

BJS द्वारा सन १९९७ से महाराष्ट्र के मेलघाट एवं ठाणे से हर वर्ष आदिवासी समाज के ५० बच्चों को निशुल्क शिक्षा हेतु पुना के इगड स्कूल में प्रवेश देते हैं। इन विद्यार्थीओं को ५ वी कक्षा से १२ वी कक्षा तक पढ़ाई, लिखाई, उनको लगने वाले पुस्तके व साहित्य, कपड़े लत्ते, खाना-पिना तथा होस्टेल में रहने कि निशुल्क सुविधा इगड द्वारा की जाती है। स्कूल की पढ़ाई के अलावा इन विद्यार्थीयों को व्यक्तीत्व विकास, जरूरत मंद विद्यार्थीयों को ट्यूशन्स आदि दिया जाता है। बारहवी कक्षा के पश्चात इन विद्यार्थीयों को ट्यूशन्स आदि दिया जाता है। बारहवी कक्षा के पश्चात इन विद्यार्थीयों को प्रोफेशनल कोर्स में ॲडिमशन हो सके इस बात को ध्यान में रखकर इन आदिवासी विद्यार्थीयों को तैयार किया जाता है। उद्देश यह है, की प्रोफेशनल

बनने के बाद यह बच्चे अपने समाज की मदद कर आदिवासी समाज को देश की मुख्य धारा में लाने का कार्य करेंगे। पिछले २ दशक में इसके बेहतर परिणाम देखने को मिले है।

आपदा प्रबंधन

जैन समाज संवेदनशील समाज है। जब भी देश में कोई नैसर्गिक आपड़ा आती है, तो जरूरतमंद देशवासियों को मदद करना यह जैन समाज की प्राथमिकता रही है। पिछले दो दशक से भारतीय जैन संघठन ने देश में आह हुए सभी प्रमुख नैसर्गिक आपदा में निम्निस्थित रूप से अपना योगड़ान दिया है।

- १९९३ लातूर भूकम्पः १२०० बद्धो का कक्षा ५वी से स्नातक स्व तक शैक्षणिक पूर्नवसन
- १९९७ मेलघाट कुपोषण: ३५० बच्चों का १० वर्षों तक निरंतर शैक्षणिक पूर्नवसन
- १९९७ जबलपूर भूकम्पः ५० छात्रों का शैक्षणिक पूर्नवसन
- २००१ गुजरात भूकम्पः भात्र १० दिनों में ३६८ शालाओं का पुर्ननिर्माण कर प्रशासन को हस्तांतरण
- २००२ अकोला बाढ: १५,००० बाढ पीडितो के लिए अस्थाई आवास निर्माण करना
- २००४ त्सुनामी: अंदमान निकोबार द्वीप समूह में १ वर्ष में ११ स्कूलो एवं ३४ प्राथमिक स्वास्थ्य केन्द्रों का निर्माण कर प्रशासन को हस्तांतरण
- २००५ जम्मू और कश्मीर भूकम्प: मात्र ४० दिनों में ८७० मकान का सामान उपलब्ध कर १५,००० पीडितो को आवास प्रदान करना
- २००५-२००६ महाराष्ट्र बाढ: ५००० बाढ पीडितों को घरेलू आवश्यक उपयोगी सामग्री का वितरण
- २००८ बिहार बाढ: १,५०,००० बाढ पीडितों को १८१ दिन निरंतर चिकित्सा सुविधा प्रदान करना

2093 महाराष्ट्र अकाल: महाराष्ट्र के बीड जिले में १९५ सुखा प्रभावित तालाबों का सफाई कार्च (Desilting) मात्र १ माह मे किया, २० लाख लिटर पानी की क्षमता इन तालाबो में बढ गई। तथा Silt के माध्यम से पांच हजार एकड़ बंजर भूमी को उपजाऊ बनाने का कार्य किया।

७ सुखा प्रभावित जिलों में १०,००० पशुओं के लिए २८ पशू शिबिरों की स्थापना कर प्रबंधन का कार्य किया।

सन १९९३ से अबतक BJS ने आपदा प्रबंधन के कार्योकी सराहना महाराष्ट्र विधान सभा से लेकर भारत की लेकसभा में की गई। राष्ट्रीय आपदा प्रबंधन प्राधिकरण (NDMA) व आयआयएम रायपुर ने ३ दिसंबर २०१३ को आपदा प्रबंधन क्षेत्र में उच्चतम काम करनेवाले ९ संस्थाओं को गौरवान्वित किया उसमें ८ सरकारी संस्थाएँ थी व BJS ही एकमात्र स्वयंसेवी संस्था को यह पुरस्कार प्राप्त हुआ।
